Program Requirements:

To complete the degree, students must pass courses totalling 240 units (generally made up of 24 courses worth 10 units each). The academic program has three distinct components: core courses, a major sequence and elective courses.

To satisfy the requirements for the Bachelor of Commerce degree program you must complete:

1. A total of, but no more than, 240 units (generally made up of 24 courses worth 10 units each)
2. No more than 100 units at the 1000 (first year) level
3. Between 40 and 100 units at the 2000 (second year) level and 3000 (third year) level
4. The Core Bachelor of Commerce courses must be completed by all students and consists of seventy (70) units of prescribed courses and ten (10) units of directed courses. All core courses are at the first year (1000) level.
5. The Compulsory and Directed courses for at least one major sequence.
6. The remaining units (electives) can be chosen from any discipline area within the University.
